Reavis High School Freshman/Transfer Registration Requirements

Illinois law provides that the residence of a student is deemed to be the same as the residence of the person who has legal custody of the student and permits only students who are residents of the School District to enroll. The person claiming custody must also reside in the District. To assist the District in determining residency and legal custody, this form must be completed. The District may investigate the residency of any student before or after enrollment and require the involved persons to provide additional information to be considered by the District in determining residency. Enrollment is not completed and attendance will not be permitted, until all residency issues are resolved.

<u>All families are required to provide originals for document verification</u>. Copies of the documents will be retained in the student record. <u>Copies can be made for a flat fee</u> <u>of \$3.00</u> if you are unable to provide them. Please bring the following documents:

□ Original Birth Certificate/Birth Abroad Certificate - Passports will NOT be accepted in lieu of a birth certificate/birth abroad certificate. If applicable, custody paperwork must be on file.

Academic Records:

Incoming freshmen must supply a copy of their 8th grade report card along with standardized test scores from 7th or 8th grade. If student is a current freshmen and/or transfer student the following documents must be submitted from your current high school.

- 1. Physical/Dental
- 2. Withdrawal
- 3. ISBE form 33/78 or Letter of Good Standing
- 4. Unofficial Transcript
- 5. Current Grades

If Applicable:

- 1. Special Education-current IEP, last Eligibility, and last Psych Report
- 2. 504 current 504 plan
- 3. ELL Test scores (if multiple languages are spoken, student must be tested if scores are not provided)
